

ARTIST BRIEF: Mural Artwork for two locations bordering Horse and Groom Square, Goldthorpe, Barnsley, South Yorkshire.

Part of Goldthorpe Towns Fund Deal Investment Programme

















1. KEY DETAILS

About:

Through this open call Barnsley Council and Beam are seeking to commission an experienced mural artist (or artist collective/ collaboration) to develop vibrant and exciting artwork for two adjacent walls bordering the new public realm area of Horse and Groom Square, Goldthorpe. The single height walls include part of Goldthorpe Library and the rear wall to the Square. The artist will undertake local research and engage with community groups and stakeholders to inform and guide the concept for the artwork, which will draw from the rich heritage of the area, and look to its exciting future.

The new artwork will positively enhance the new Horse and Groom Square which is a key community resource and hub at the heart of the town, encouraging greater engagement and connection to the place.

All inclusive budget: £20,000 plus VAT if applicable

Timeframe: December 2024 - May 2025

2. ABOUT THE COMMISSION

2.1 Aims

- To engage with local residents to inform the design and delivery of vibrant new paint to surface mural artwork for walls on two adjacent sides of the new Horse and Groom Square, Goldthorpe.
- The design will be contemporary and informed by place specific research and community engagement to ensure the work is meaningful for local residents.

2.2 Context

Goldthorpe is at the heart of the Dearne Valley in the eastern Pennine foothills of South Yorkshire, between the towns of Barnsley, Rotherham and Doncaster and at the eastern edge of the Metropolitan Borough of Barnsley. It is an identified Principal Town in the adopted Local Plan, acting as the shopping and service centre for the adjoining villages of Thurnscoe (north) and Bolton upon Dearne (south).

<u>Towns Fund Deal Goldthorpe</u>: More than £23.1m investment is going to help Regenerate, Renew and Revitalise Goldthorpe, Thurnscoe and Bolton upon Dearne through the Towns Fund. Final business cases for five major projects have been approved by Barnsley Council's Cabinet and government. This means the £23.1m is being released gradually in stages now and the projects are underway. <u>Read more.</u>

<u>Vision and aim of the Towns Fund Programme</u>: The investment in Goldthorpe will create a new Cultural and Community Hub, new visitor facilities at Phoenix Park, refurbish housing stock, develop employment land, and improve public spaces across the area. Through this project we are committed to transforming lives, our economy, how people understand place, using our heritage in new and exciting ways, and to be just as much about the future as we are about the past.

Horse and Groom Square

As part of the Towns Fund Deal delivery, a new public realm area, Horse and Groom Square has been delivered, opening in 2023, which is the location for the proposed mural artwork. Funded by the UK Towns Fund through the Goldthorpe Town Deal, the square hosts a weekly market and public events, you can see how the site was transformed into an attractive new public square here.

Goldthorpe Library Transformation

Goldthorpe Library is currently being transformed into a modern and flexible library space, as part of a wider programme of library refurbishment across the borough funded by the UK Shared Prosperity Fund. The Library closed for works at the end of September and is expected to re-open in early 2025. The makeover includes new furnishings, alongside works to make the building more sustainable and energy efficient, which aligns with Barnsley Council's Sustainable Barnsley ambition. Read more here. With one of the proposed walls for the artwork being part of the Library there is an exciting opportunity for the artwork to support the reopening and reinvigoration of the Library, making a visual connection between the two key community resources of Goldthorpe Library and Horse and Groom Square.

2.3 Sparking Ideas

To help kick start your creative ideas we have collated some information about the area and previous engagement projects which may act as inspiration as you develop your ideas.

- Heritage and social history connected to the former Horse and Groom pub, after which the new Square is named, and which sat on the site for many years, prior to becoming disused and derelict. In 2021 it was demolished to make way for the regeneration works. Read more.
- Dearne Community Arts Festival has gathered <u>a number of oral histories</u> about the pub and life in the town which may be of interest.
- Barnsley Museums has been delivering a number of creative projects exploring the stories of the local area. <u>Storying Goldthorpe.</u>
- RSPB Old Moor is located in the local area, so connections to biodiversity could be explored.
- Since the closure of the mining industry in the 1980s, the area has benefitted from central government investment and council interventions, working always towards giving renewal; new opportunities to the area/ residents/ visitors/ improved quality of life through new job opportunities.
- The area has a history of agriculture, supporting links to themes of growth.
- The area has a strong history of sport linking to themes of health and wellbeing,
 e.g.
 - Dorothy Hyman a former sprinter competing in the 1960 Rome Olympics (Silver & Bronze) 100m & 200m and 1964 Tokyo Olympics (Bronze) Relay 100m events winning 3 medals in total, who trained at the former Hickleton Main YC located in Thurnscoe;
 - Billy Thompson (boxer) from Thurnscoe was British Lightweight Champion (between 1947 & 1951 and European Champion from 1948 to 1949;
 - Luke Cutts from Thurnscoe has won 4 successive British Indoor Championship gold medals.
 - Goldthorpe's Welfare Park is home to a thriving Football and Cricket Club & the secondary school Dearne Astrea Academy;
 - Barnsley College and Dearne Valley College are establishments which will provide opportunities for sporting development.
- Towns Fund is supporting the regeneration of the former Miners Welfare, now
 Dearne Playhouse and grounds. The Dearne Playhouse led the "Heart of the
 Wood" story and live theatre production about the future of the mining
 communities, the hopes and dreams and practical aspirations of the children and

grandchildren and great grandchildren of mining families and others growing up today in those communities.

2.4 Objectives

- To create a high quality and robust artwork which is relevant to the local community and attractive to visitors.
- To work in close collaboration with the project team to ensure the artwork integrates with and complements the existing public realm area.
- Artwork to require minimal maintenance, and should include mitigations against vandalism e.g. anti-graffiti coating.
- To create a lasting legacy supporting a positive enhancement to the area and having a positive impact on residents engaged through the process.

2.5 Deliverables

- Liaison with and attendance at project meetings with Beam and wider team during the process as applicable. Please note that the majority of communications and meetings can be done remotely.
- Paint to surface mural artwork to walls on two adjacent sides of Horse and Groom Square as detailed in Section 3.
- Minimum expected lifespan for the artwork is 5 years.
- Targeted community group and stakeholder engagement must inform the process
 activities to be agreed in advance with Beam.
- Undertake research to feed into place specific designs.
- Presentation of concept and detailed design proposals to the Project Steering Group with Beam.
- The artwork must be durable, weatherproof, and vandal-resistant with a clear maintenance plan and thoughts regarding decommissioning in place.
- The Artist will be required to (or work with their sub contractor/s to) design, fabricate and install their work including arranging the necessary equipment for safe installation and liaise with Beam to ensure all required information is available for a Risk Assessment Method Statement (RAMS).
- Supply content to support the submission of any necessary permissions required, e.g. Planning Application / Permission to install Apparatus in the Highway / Traffic Management if applicable.

- Record details of engagement activities undertaken for monitoring and evaluation purposes.
- Artists will be required to have their own Public Liability Insurance and work in accordance with Barnsley Council's health and safety and child protection guidance.

3. ABOUT THE SITE

An aerial view showing the new Horse and Groom Square public realm area is provided below. The two proposed walls for artwork are single storey walls to the left (library building) and rear of the square on the image shown below.

There is the potential to create a striking visual narrative to tie together this corner of the square and amplify the existing high quality public realm works.

3.1 Overview

Rear wall details:

- Material brick and mortar
- Indicative measurements, Height 1.65m x Length 25m.

Library wall details (single storey section only):

- Material brick and mortar
- Indicative measurements, Height 2m x Length 20m.
- There are narrow windows along the top of the wall.

3.2 Considerations

- Both walls are in the ownership of Barnsley Council
- It is not envisaged that mural artwork here will require planning permission
- As both walls are single storey height there may be potential for young people to support some aspects of painting the wall as part of the community engagement aspect of the project, to be guided by the appointed artist.

 - o Previous experience of community engagement to inform design development.
 - o Understanding of safety considerations when working in the public realm.
